PATENT Association

Court monitoring and utilizing its experiences in intimate partnership violence cases

Project description

Aims:

- To introduce the practice of court monitoring in legal cases of intimate partnership violence (IPV), and in other types of discrimination cases, as well.
- To achieve that in the course of legal education, IPV becomes permanently thematized, and legal professionals acquire appropriate knowledge and skills in this area.
- To assure the quality of the legal aspects of victim aid services in Hungary.
- To initiate changing legal practice in an area where legal regulation itself has improved in the past few years but legal practice has not followed this development.
- To have courts handle IPV cases as a separate case group.
- To raise social awareness and reduce the frequency of IPV.
- To enable NGOs working with other types of violence and discrimination cases (e.g. LGBT people, Roma people) apply our methodology and experiences as good practice.
- To increase the transparency of court proceedings and to strengthen civic control and activity.
- To involve abused women in the attainment of legal changes affecting them.
- To advance gender equality.

Main activities:

- Monitoring court proceedings
- Training judges and compiling a training material
- Trainings at legal clinics
- Dissemination of the methodology portfolio of court monitoring
- Capacity building for NGOs working with DV victims with respect to legal service provision
- Involving the experiences of abused women in the production of training materials
- Strategic planning
- International conference
- Dissemination

Expected results at the end of the project:

- 50 new and at least 10 old volunteers participate at our trainings. A network of local coordinators (future volunteer trainers) gets formed. The professional knowledge of our volunteers increases and becomes more thorough. Their work has a mobilization impact, as well.
- Experience-sharing interviews with abused women: we have conducted 15 interviews with victims of IPV who shared their experiences about authorities and courts. Their experiences will be incorporated into the judge training material and the final report.
- Legal Clinics: contributing to the professional development of legal experts and law students; dissemination impact (4 legal clinics, at least 40 people).

- NGOs working with victims / women's NGOs: capacity building for 4-5 NGOs, quality assurance of the legal aspects of victim aid services. Participants so far: Holdam Association (Miskolc), BFKH Victim Aid Department, a group in Veszprém which is being established, Temporary Home for Families (Mosonmagyaróvár).
- Advocacy NGOs of other discriminated minorities: at least 2 (LGBT, Roma) organisations, at least 10-10 (i.e. 20) people. Result: dissemination of methodology.
- Strategic planning: work with professionals in NGOs working on increasing the transparency of court operations (30-50 people). Result: capacity building and increasing the expertise of organisations.
- Training materials: ready-made, applicable and adaptable, two-semester long seminar material for legal clinics; developing the material for training judges.

Organisational aspects:

- The project is innovative and it is a significant step forward in the life of PATENT: strengthening the training elements corresponds with our medium-term strategic plan.
- We increase the social acceptance of our aims: we lay great emphasis on communication and the dissemination of our experiences and the conclusions of the project (mailing lists of NGOs, community pages, websites, press, broader public).
- Members of PATENT and some of the volunteers will become more experienced trainers.
- The volunteer recruitment increases our mobilisation capacities.
- Our working and organisation methods increase the transparency of PATENT.
- Strategic planning with other NGOS and the dissemination of experiences and methodology strengthens cooperation among NGOs.

Project activities:

- 1. *Training of court monitoring volunteers*: compilation of methodology portfolio; recruiting and training of volunteers (old and new volunteers, trainers and local coordinators). Developing training materials. Staff: our legal experts and psychologists, volunteer coordinator.
- 2. Court monitoring: observation of court proceedings, note-taking (with special attention to the protection of personal data), case research and analysis, correspondence with volunteers, supervision. Staff: our legal experts and psychologists, volunteers, volunteer coordinator.
- 2. Feeding back the results of monitoring into the operation of courts: sensitizing trainings for judges; compilation of training material for judges. Staff: our legal experts and psychologists.
- 3. Development of a two-semester long training material for seminars at the legal clinics of faculties of law: compilation (based on existing research and project experiences) and dissemination of training material. Staff: our legal experts.
- 4. Dissemination of the methodology portfolio of monitoring: methodology training for NGOs doing advocacy for other discriminated groups. Development of training material, communication, correspondence. Report writing. Staff: our legal experts and psychologists, volunteers.
- 5. Capacity building for NGOs working with victims / women's through legal trainings: compilation of training materials; conducting trainings. Staff: our legal experts and psychologists.

- 6. Experience-sharing interviews with abused women: experience sharing, recording, collecting of examples, incorporating their experiences into training materials and the final report. Staff: our legal experts and psychologists.
- 7. Strategic planning with other NGOs: Negotiations with other organisations (possible joint goals: e.g. the integration of the legal institution of *amicus curiae*; the reform of minutestaking). Staff: our legal experts and psychologists, project coordinator.
- 8. Conference: topic: the publicity and transparency of the work of courts, the integration of the legal institution of *amicus curiae*; the reform of minutes-taking. Organising and staging the conference, reaching the media and professional and civic publicity. Staff: project coordinator, financial coordinator, our legal experts and psychologists, volunteers.
- 9. Reaching out to the professional and broader public: blog, project closing press conference, regular reports on community pages, civic fora, civic mailing lists and our website. Writing and dissemination of final report in Hungarian and English. Staff: our legal experts, the project coordinator, our communication expert, volunteers, translator.
